The National Science Foundation's Louis Stokes Alliances for Minority Participation (LSAMP) is a multidisciplinary undergraduate program featuring an organizational structure of multiple institutions working together toward a shared goal. These alliances include partners from two-and four-year degree granting higher education institutions, business and industries, national research laboratories, and local, state, and federal agencies. The overarching aim of the partnerships, to increase significantly the quantity and quality of underrepresented minority students who graduate with a degree in science, technology, engineering and mathematics (STEM) disciplines, is shared by all partner institutions, laboratories and agencies. Federal agencies, such as the National Institutes of Health (NIH), Department of Energy (DOE) and Smithsonian continue in partnership and collaboration with LSAMP. A partial list of other partners begins on page 22 of this document.



Currently, 30 alliances with approximately 400 institutions, ranging from citywide (e.g., New York City), to statewide (e.g., California, Oklahoma, Illinois, North Carolina), to multistate (e.g., Florida-Georgia, Massachusetts-Rhode Island-Connecuticut, Alaska-Hawaii-Washington), to the U.S. Commonwealth, Puerto Rico, are supported by the LSAMP program. The All Nations-LSAMP comprising 52 partners in 12 states, and the Western Alliance to Expand Student Opportunities (WAESO-LSAMP) with 41 partners in six states, are the larger and more wide ranging of these partnerships. In contrast, in terms of number of institutions, the University System of Maryland-LSAMP with three partners, is the smallest. Notably, the LSAMP partnerships bring together public and private institutions that are Majority Schools, (many are Research I), Historically Black Colleges and Universities (HBCUs), Hispanic Serving Institutions (HSIs), Tribal Colleges (TCs), and Community Colleges (CC).

The 2000 Westat Report* studied programs at NASA, NIH, and NSF which promote participation of underrepresented undergraduate students in STEM fields. This study identified six keys to LSAMP's success as follows:

- *Summer bridge programs*
- *Research experience*
- *Mentoring*
- *Drop-in centers*
- *Caring staff*
- *Alliance structure*

Also, the study reported a high degree of cooperation between alliance members; while at the same time, each partner retained autonomy in conducting its program.

The national program vision coupled with shared best practices, good communication, collaborative decision-making, strong leadership, professional respect and trust between institutions, are also hallmarks that provide linkages to success in LSAMP partnerships and collaborations. Despite the enormous challenges of managing an alliance, the recorded synergy remains a clear strength of these partnerships. In these pages alliance membership and contact information, for each partner, is provided. Also, a partnership summary and distribution map are included.






