




The LSAMP program is aimed at increasing the quality and quantity of students successfully completing science, technology, engineering and mathematics (STEM) baccalaureate degree programs, and increasing the number of students interested in, academically qualified for and matriculated into programs of graduate study. LSAMP supports sustained and comprehensive approaches that facilitate achievement of the long-term goal of increasing the number of students who earn doctorates in STEM fields, particularly those from populations underrepresented in STEM fields.



### Alliances for Success A. James Hicks, LSAMP Program Director

Similar to the first edition, this 2006-2007 Louis Stokes Alliances for Minority Participation (LSAMP) partnership publication contains a profile of each alliance, contact information, a partnership summary table, and a distribution map. Notably, the number of colleges, universities, and other alliance partners exceeds **500** in number (see page 9).

The National Science Foundation's LSAMP program is a multidisciplinary undergraduate program featuring an organizational structure of multiple institutions working together toward a shared goal. These alliances include partners from two-and four-year degree granting higher education institutions, business and industries, national research laboratories, and local, state and federal agencies. The overarching aim of the partnerships, to increase significantly the quantity and quality of underrepresented minority students who graduate with a degree in science, technology, engineering and mathematics (STEM) disciplines, is shared by all partner institutions, laboratories and agencies. Federal agencies, such as the National Institutes of Health (NIH), Department of Energy (DOE) and Smithsonian continue in partnership and collaboration with LSAMP.

Currently, 35 alliances with approximately 472 institutions, ranging from citywide (e.g. New York City), to statewide (e.g. California, Oklahoma, Illinois, North Carolina), to multi-state (e.g. Florida-Georgia, Massachusetts-Rhode Island-Connecuticut, Alaska-Washington), to the U.S. Commonwealth, Puerto Rico are supported by the LSAMP program. [Islands of Opportunity] initiated in 2006, is the newest alliance in the LSAMP portfolio. It is based in Hawaii and covers Hawaii, America Samoa, Marshall Islands and Guam. The Western Alliance to Expand Student Opportunities (WAESO-LSAMP) with 4l partners in six states, and the All Nations-LSAMP comprising 36 partners in 12 states, are the largest and wider ranging of these partnerships. In contrast, in terms of number of institutions, the University System of Maryland-LSAMP with three partners is the smallest. Notably, the LSAMP partnerships bring together public and private institutions that are Majority schools, (many are Research I), Historically Black Colleges and Universities (HBCUs), Hispanic Serving Institutions (HSIs), Tribal Colleges (TCs), and Community Colleges (CCs).

The 2000 Westat Report\* studied programs at NASA, NIH and NSF. The report highlight agency programs that promote participation of underrepresented undergraduate students in STEM fields. This study identified six keys to LSAMP's success as follows:

Summer bridge programs Research experience Mentoring Drop-in Centers Caring staff Alliance structure

Also, the study reported a high degree of cooperation between alliance members; while at the same time, each partner retained autonomy in conducting its program. Findings from a new and more in-depth evaluation report conducted by the Urban Institute (UI) were released in 2006. 
